

RESOLUTION NO. 84-164

WHEREAS, the present legal name of the Airport is the Dallas-Fort Worth Regional Airport; and

WHEREAS, for informal and signage purposes, the Board authorized the name, "Dallas-Fort Worth Airport" by Resolution No. 71-81 adopted October 5, 1971; and

WHEREAS, because of the Airport's growth and its designation by the United States Customs Service as a United States port of entry, its present name no longer accurately describes its status; and

WHEREAS, the Board desires to change the name of the Airport for all purposes to the Dallas-Fort Worth International Airport in order to more accurately describe its status; and

WHEREAS, the Board understands that an amendment to the Contract and Agreement between the Cities will be necessary to change the Airport's name as hereinabove described, for all purposes; NOW, THEREFORE,

BE IT RESOLVED BY THE DALLAS-FORT WORTH REGIONAL AIRPORT BOARD:

SECTION 1. That the Board hereby recommends and requests that the City Councils of the Cities of Dallas and Fort Worth amend the Contract and Agreement between the two Cities to change the Airport's name to the Dallas-Fort Worth International Airport, such change to become effective on and after January 1, 1985.

SECTION 2. That this Resolution take effect immediately from and after its passage.

THIS AGREEMENT, is entered into and effective January 1, 1985, by and between the CITY OF DALLAS, TEXAS, a municipal corporation acting by and through its duly authorized City Manager, and the CITY OF FORT WORTH, TEXAS, a municipal corporation acting by and through its duly authorized City Manager:

WITNESSETH:

WHEREAS, the Parties hereto did, by that certain Contract and Agreement dated April 15, 1968, provide for the construction and operation of the Dallas-Fort Worth Regional Airport and continued, expanded and further defined the powers and duties of the Dallas-Fort Worth Regional Airport Board; and

WHEREAS, the Dallas-Fort Worth Regional Airport Board, on September 11, 1984, recommended that the City Councils of the Cities of Dallas and Fort Worth amend the Contract and Agreement to change the name of the Airport, for all purposes, to the Dallas-Fort Worth International Airport; and

WHEREAS, the City Councils of the Cities of Dallas and Fort Worth, by ordinances passed on December 19, 1984, and December 18, 1984, respectively, authorized execution of an amendment to the Contract and Agreement changing the name of the Airport, for all purposes, to the Dallas-Fort Worth International Airport;

NOW, THEREFORE, the Cities of Dallas and Fort Worth, Texas hereby agree as follows:

SECTION 1. That the certain Contract and Agreement between them, dated April 15, 1968, is hereby amended by adding the following Section 20:

"20.
NAME CHANGE

Effective January 1, 1985, and for all purposes, the name of the Airport shall become the DALLAS-FORT WORTH INTERNATIONAL AIRPORT, and the name of the Board shall become the DALLAS-FORT WORTH INTERNATIONAL AIRPORT BOARD. Effective that date, Dallas-Fort Worth

International Airport and Dallas-Fort Worth International Airport Board shall be used wherever the use of Dallas-Fort Worth Regional Airport or Dallas-Fort Worth Regional Airport Board, respectively, is required by this Agreement. Effective the above date, "Airport", "Regional Airport" or "Dallas-Fort Worth Regional Airport", where appearing in this Agreement, shall refer to and mean the Dallas-Fort Worth International Airport; and "Board", "Airport Board" or "Dallas-Fort Worth Regional Airport Board", where appearing herein, shall refer to and mean the Dallas-Fort Worth International Airport Board."

SECTION 2. Except as expressly amended by this Agreement, the Contract and Agreement shall remain in effect in its entirety.







AN ORDINANCE AUTHORIZING AN AMENDMENT TO THE CONTRACT AND AGREEMENT BETWEEN THE CITIES OF DALLAS AND FORT WORTH TO CHANGE THE NAME OF DALLAS-FORT WORTH REGIONAL AIRPORT TO DALLAS-FORT WORTH INTERNATIONAL AIRPORT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Cities of Dallas and Fort Worth, by that Contract and Agreement dated April 13, 1968, provided for the construction and operation of Dallas-Fort Worth Regional Airport and continued, confirmed and established the Dallas-Fort Worth Regional Airport Board as its operating Board of Directors; and

WHEREAS, because of the Airport's growth and its designation by Customs as a United States Port of Entry, its present designation as a "Regional" Airport is no longer accurate; and

WHEREAS, by Resolution dated September 11, 1984, the Dallas-Fort Worth Regional Airport Board recommended that the Cities of Dallas and Fort Worth amend the Contract and Agreement to change the Airport's name to Dallas-Fort Worth International Airport effective January 1, 1985; and

WHEREAS, the City Council of the City of Fort Worth desires to change the Airport's name to the Dallas-Fort Worth International Airport in order to more accurately describe its status; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WORTH, TEXAS:

SECTION 1.

That the City Manager be and is hereby authorized to execute an amendment to that certain contract entitled Contract and Agreement between the City of Dallas and the City of Fort Worth, dated April 13, 1968, to change the name of Dallas-Fort Worth Regional Airport to Dallas-Fort Worth International Airport and the name of the Dallas-Fort Worth Regional Airport Board to the Dallas-Fort Worth International Airport Board, effective January 1, 1985.

SECTION 2.

That this ordinance shall take effect and be in full force and effect from and after its passage, and it is so ordained.
